

Participatory Arts Policy Statement – Members **approved** the Participatory Arts Policy Statement for publication.


MDA Policy Statement – Members **approved** the Multidisciplinary Arts Policy Statement for publication.




Members **approved** the report and recommendations of the Audit and Risk Committee and noted that a written report will be brought back to the next meeting.
